Grooming	I understand that PCaK is NOT responsible for grooming but will endeavour to return my pet in a clean and tidy state. Puppies

Only house-trained puppies are allowed to board at PCaK.. Please read this section carefully if you are bringing a puppy into the kennels.



I agree that NON house-trained puppies need far more attention – feeding and cleaning – than those that are house trained. Should my pet NOT be house trained then I understand that PCaK will levy an ADDITIONAL charge of £20 PER DAY as payment for the extra work.



Kennel cough



Kennel Cough is a fairly common and highly contagious respiratory disease in dogs.

Even in a scrupulously clean environment like Pineview's kennels, this distressing illness can strike.

It is impossible to safeguard against Kennel Cough. It has a three day incubation period, so dogs that appear perfectly healthy when entering the kennels may be carrying one of the viruses that cause the problem.

I understand there can be costs involved following an outbreak of Kennel Cough and that PCaK or its insurers is not responsible or liable for any costs I may incur.

I also understand that this does not interfere with my statutory rights.



Cat Flu



Cat Flu is a distressing illness which can occasionally be brought into boarding catteries.

I expect that when I leave my cat at Pineview he or she will be well cared for and returned happy and healthy.

I understand that PCaK or its insurers is not responsible or liable for any costs I may incur should an outbreak of Cat Flu strike the Pineview cattery.

I also understand that this does not interfere with my statutory rights.
